Proposed LWCA By-Laws Amendment

The LWCA Board of Directors is proposing an amendment to our by-laws. The recommendation is for the Association to operate on a balanced budget each year and create a minimum reserve. This change would be added to Article V, as exhibited below.

This matter will be brought up and voted on at the next General Meeting, on **June 4, 2015**.

ARTICLE V DUES & ANNUAL BUDGET

Section 1. Annual dues per household shall be set by the Board of Directors and will be due in September.

Section 2. Only paid members may participate in annual elections and vote at General and Special Meetings.

Section 3. The Association shall operate on a balanced budget each year, as proposed by the Board.

Section 4. The Association annual budget shall allow for no less than a \$2,000 reserve. This reserve fund shall be used for emergency purposes, or for reasons the Board should deem necessary. Said use will be announced to the membership prior to a General Meeting. ☺

Lake Walker Community Association Formal Affiliation with Greater Homewood Community Corporation

TO BE VOTED ON BY THE DUES-PAYING MEMBERS OF THE ASSOCIATION AT THE JUNE 2015 GENERAL MEETING.

The Board of Directors are volunteers who try diligently to represent the residents of the Lake Walker Community. We struggle every day to make decisions that are in the best interest of all residents living in our boundaries. We all have different backgrounds, from the for-profit sector to those of us familiar with the non-profit arena.

A few months ago we were faced with the need to apply for a community grant to support our block party in September. The application required a fiscal sponsor who was a 501(c)(3). In the past Greater Homewood Community Corporation had been a fiscal sponsor, but due to recommendations of their tax specialist, they were no longer offering this service to programs not under their oversight.

History has it that the LWCA at one time explored obtaining its own 501(c)(3) status but alone did not qualify. The known benefit was there. This recent situation led to an extended conversation as well as through exploration of the risks/benefits

of becoming an actual program of GHCC.

A non-profit status would bring the ability of actual tax-exempt monetary contributions directly to projects that LWCA wishes to pursue. The Board of Directors met several times to debate becoming an official program of Greater Homewood Community Corporation. These discussions created some insightful questions about this potential change. After great deliberation we have come to a consensus in proposing to the entire LWCA members that our association form an official relationship with GHCC. We all agreed if we didn't give it a try we would not be able to realize the benefits. By becoming a program under GHCC we would retain our own board structure; we would retain our operating bylaws; and we will continue to drive the direction of our activities.

WHAT DOES IT ALL MEAN?

I will highlight a few items below but we will be posting three specific documents that outline in great detail the formal affiliation. Please review these documents and please present questions on the LWCA forum in which we will respond.

Simply, these changes affect operations in this way:

- We will no longer have our own checking and PayPal Accounts.
- GHCC will provide all financial oversight (an outside entity allowing for sound financial operations whereby they will provide fiscal reporting to the LWCA Board as well as the entire community).
- We will be tax-deductible in qualifying purchases/donations.
- We will be under the auspices of GHCC Liability Insurance (we have never had this protection).
- Cost to the Association is 5% of all deposits. (For example if we have income of \$4,000 then the cost of this fiscal sponsorship is \$200 a year.)

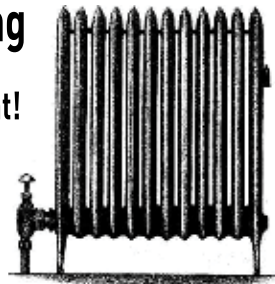

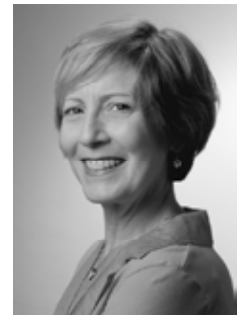
